A request was made to have the footpath on the Prickwillow road cut to improve accessability for walkers however the path in question is not a legally designated footpath. The County Council are responsible for cutting the verges. Individual users of the path can apply to the County Council to request that it is designated as a footpath as this is not a PC matter. CCllr Palmer will look into the matter at the County Council. The concrete path along Coates Drove is very overgrown and the Council will arange to have it cut back.
