Mr Fleet: Can the council please explain the difference in the amount of money recorded for the sale of the cemetery land and the amount recorded in the annual report?

The total income received was £764,929 which included a deposit of £20,000 paid in the previous financial year and £36,000 in section 106 monies which has been paid to ECDC and can be reclaimed by the council for specific Isleham project leaving a balance of £708,930 as shown on the annual report.

How do the council expect the village to subsidise the new community centre when the village hall lost £24,420 according to the figures recorded in the annual report.

Are the costs for the new community centre being kept separate from the village running costs?

The chairman explained to Mr Fleet that all the figures were not available at the meeting. If in future he would like to put the questions in writing a week before the meeting then the answers would be available.

A reply will be given in due course with the necessary figures.

Mr Flatt: - The figures should not be included in the annual report if they are not accurate.

Community centre figures have been included in village hall nominal code.

Different nominal codes can be set up to show the community centre as a separate entity.

Mrs Clarke: Can the council explain why we paying for a loan which we haven't got yet?

The council has had to put up the precept to cover the cost of the loan because the first repayment is likely to be in this financial year.

Will the money be ring-fenced to pay off the loan?

If no repayment is made the money will be put into ear-marked reserves at the end of the year. This cannot necessarily go to paying off the loan in the first instance as charges are incurred if early repayments are made.

What will happen to the Centre if the management committee can't make a go of it? In the event of this being the case the Centre will come back to the Parish Council.

Mrs Clarke made it clear she is not happy that the Centre has been put out to a group other than the PC to manage.

Mr Powley was asked if the County Council run any feeder buses anywhere in the county; he was unable to think of any and pointed out that money is very tight at Shire Hall and that they are not in the position they would like to be, and any service subsidised must be very carefully considered. A VBS and PW will meet with the Clerk to discuss the possibilities and prepare a proposal to send to the County Council.

d) Last year the council briefly employed Mr Wilding to grit the footpath by the school. It was felt that arrangements should be in place again this year should the weather deem it necessary. There are other areas in the village that are dangerous when it is icy and it is hoped that volunteers will come forward to see that the areas are gritted.

It was proposed by PC and seconded by SB that the Council make similar arrangements for this year in line with the guidelines provided by the County Council.

The question was raised as to whether the parish council would consider a trade off if houses were built there e.g. An exchange of land for allotments and even the possibility of a new school. The CC wish to realise their asset for housing; if the council could secure a new school would this be a good option for us?

A full market scheme would necessitate a 30% affordable housing allocation. Questions were also raised about the possibilities of bus services in the village.
